22 Pursuant to A.R.S. § 38-431.02, notice is hereby given to the members of the  
23 general public, the parties, and the Arizona Power Plant and Transmission Line Siting  
24 Committee (“Committee”), that the Committee will hold a public meeting/hearing on the  
25 above application that is open to the public at the High Country Conference Center’s 1899  
26 Ballroom, located at 307 West Dupont Ave. Flagstaff, AZ 86001, commencing on  
27 September 7, 2023, at 10:00 a.m., and will continue September 8, 2023, as necessary, at  
28 the same location beginning at 9:00 a.m. on each day, unless a tour is taken. If a tour is  
taken, it will begin on an alternative date and time set by the Chairman of the Committee  
 (“Chairman”).

Public comment will be taken in a special evening session on September 7, 2023 at  
5:30 p.m. and may be taken at the beginning of each hearing day or at other times during  
the hearing at times designated by the Chairman. Unless later ordered by the Chairman,  
the hearing will adjourn at approximately 5:00 p.m. each day, except on September 7,  
2023, when it will continue after 5:00 p.m. for the public comment session.

No tour of the Project area is planned by the Chairman at this time. If the  
Chairman or Committee later decides to conduct a tour, notice that includes a map and

1 itinerary of any such tour will be available at the hearing and posted on the Project website

4 The hearing may conclude earlier or later than anticipated, depending upon the  
5 number of parties that intervene, the amount of testimony presented, the amount of public  
6 comment, and the time needed for deliberations by the Committee. As a part of the public  
7 meeting/hearing, members of the Committee will discuss the potential value of a tour, and,  
8 at the discretion of the Chairman, may tour the location of the proposed project area as set  
9 forth above.

10 **THE PUBLIC HAS THE OPTION TO PARTICIPATE BY EITHER**  
11 **WATCHING THE MEETING ONLINE OR LISTENING TO THE MEETING VIA**  
12 **TELEPHONE.**

13 At least 24 hours in advance of the hearing, information regarding online and  
14 telephone hearing access as well as any additional details regarding safety protocols or  
15 other revisions to the hearing schedule, will be posted on the Applicant's Project website

21 ACC websites. **NOTE: NOTICE OF ANY SUCH RESUMED HEARING WILL BE**  
22 **GIVEN; HOWEVER, PUBLISHED NOTICE OF SUCH A RESUMED HEARING**  
23 **IS NOT REQUIRED.**

- 18 7. If it is decided a tour would be valuable, the Committee will meet at the  
19 hearing site. The members of the Committee will tour the project. Members  
20 of the public may follow the Committee's tour. No testimony or discussion  
21 with or between Committee members about the application or matters  
22 relating to the application will take place, except on the record before a court  
23 reporter at the designated stops. The Chairman will make any procedural  
24 decisions concerning stops at different points of interest;
- 25 8. Discussion of proposed findings of fact, conclusions of law, the certificate of  
26 environmental compatibility and conditions to the certificate of  
27 environmental compatibility;
