RESPONSE TO COMMISSIONER KENNEDY'S LETTER DATED FEBRUARY 7, 2011 February 18, 2011

UNS Gas, Inc. ("UNS Gas" or "Company") hereby responds to the questions posed in Commissioner Sandra Kennedy's letter dated February 7, 2011, as follows:

I. INTRODUCTION.

During the time period between February 3 and February 8, 2011, natural gas outages occurred in southern Arizona, within Southwest Gas Corporation's ("SWG") service territories. Commissioner Kennedy issued a letter, dated February 7, 2011, addressed to SWG, UNS Gas, El Paso Natural Gas Company ("EPNG"), and Transwestern Pipeline Company, LLC ("TW") regarding the outages. UNS Gas did not experience a gas outage during this time. Accordingly, UNS Gas's responses to some of the questions indicate that the question does not apply to the Company, or that the Company defers to the other gas utilities. UNS Gas is committed to working with the Arizona Corporation Commission ("Commission") and the other utilities to better understand what occurred and what can be done to avoid or mitigate future outages.

II. RESPONSES TO QUESTIONS.

1) In your opinion, what caused the outages to occur? Please provide as much detail as possible.

RESPONSE:

UNS Gas does not have first-hand knowledge of what caused the outages. The Company defers to SWG's, EPNG's and TW's findings and reports as to the cause(s) of the outages.

2) Were the outages a surprise to your company or did your company have some advance warning that the impending situation could result in outages to retail customers?

RESPONSE:

The Company was informed by TW, EPNG, and SWG that pipelines in southern Arizona were undersupplied, and that gas was being curtailed in other service territories. During the outages, UNS Gas did notify Commission Staff that it was not experiencing any outages.

3) If your company did have advance warning, how much in advance of the outages was that warning and when did your company notify the Arizona Corporation Commission of the possibility of outages?

RESPONSE:

Although UNS Gas did not experience any outages for the relevant time period, the Company did make Commission Staff aware, during the outages, that it was not experiencing any gas outages.

4) Did your company have an emergency plan of some kind in place to deal with this type of situation? If no, why not?

RESPONSE:

UNS Gas's Emergency Plan is on file with the Commission, and has been reviewed by the Pipeline Safety Division. Section VI of the Emergency Plan pertains to gas outage procedures, and Section VII pertains to the coordination with local authorities when an outage occurs. Copies of Sections VI and VII are attached hereto as Exhibit A.

5) If your company did have an emergency plan in place, how did that plan work in this situation? In other words, what parts of the plan worked as desired and what parts needed improvement? For those parts that need improvement, please provide as much detail as possible.

RESPONSE:

UNS Gas did not implement its emergency plan as it experienced no outages. The Company will review its emergency plan in light of these outages to see if any modifications are warranted.

6) How were the aspects of the outage and how your company was dealing with restoring service communicated to your customers, in particular those customers that were directly impacted by the outages?

RESPONSE:

This question is not applicable to UNS Gas.

7) There is no natural gas storage in Arizona. If there would have been natural gas storage available to your company in Arizona, would that have mitigated the impact of the outages? Please provide as much detail as possible.

RESPONSE:

Whether the impact of the outages could have been mitigated by natural gas storages available in Arizona would depend upon many factors, including where the storage is located, whether that location is proximal to an interstate pipeline, and whether the interstate pipeline is proximal to the shortage/outage location. UNS Gas believes that under the proper circumstances gas storage has the potential to reduce the risk of gas outages in the future.

8) Is your company working, either on its own or in conjunction with other entities, on establishing natural gas storage in Arizona? If not, why not? If yes, please provide as much detail as possible.

RESPONSE:

UNS Gas has been a part of the Arizona Natural Gas Storage Consumer Coalition ("AGSC" or "Coalition") since December 2007. AGSC is made up of Arizona utilities interested in investigating potential gas storage projects in Arizona. Commission Staff member Bob Gray occasionally participates in AGSC discussions as well. The group has identified three potential storage projects, but none have been formalized yet. Further information regarding these potential projects has not yet been made publicly available.

9) If your company is not working on establishing natural gas storage in Arizona, do you know of any entities that are working on this issue?

RESPONSE:

UNS Gas has been working on establishing natural gas storage in Arizona through the AGSC.

Are there any other measures (other than storage) that you are considering or have considered that would help mitigate such a situation in the future?

RESPONSE:

UNS Gas has effective protocols for mitigating gas shortages, including two customers off its Southwest Forest Lateral line whose service can be interrupted in the event that low pressures from EPNG or other distribution problems occur. Additionally, UNS Gas and Tucson Electric Power Company can schedule, if available, additional gas to be purchased and delivered to the interstate pipeline if the need arises.

11) Please provide any other information that you believe would be helpful to me and the other Commissioners in this inquiry.

RESPONSE:

UNS Gas is not aware of any other information at this time, but will continue to cooperate with the Commission and other gas utilities to ensure safe and reliable service.

VI. GAS OUTAGE PROCEDURES

If, due to an emergency situation, it becomes necessary to shut-off a distribution system affecting a large number of customers, the decision must be made if possible in consultation with the following people:

Town Manager District Manager General Manager

The following procedure for a gas outage shall be followed:

A. SHUTDOWN PROCEDURE

1. DUTIES OF SUPERVISOR IN CHARGE

- a) Determine a shutdown area that would affect the least number of customers and ensure operations within the MAOP limits plus build-up allowed for operation of pressure limiting & control devices.
- b) Determine which system valves shall be operated in order to isolate the required portions of the distribution system.
- c) Notify the pipeline supplier if it becomes necessary to turn off any of the city gate stations.
- d) Determine the manpower requirements for the turn-off operation and the turn-on and relight operation.
- e) If service technicians from other towns must be used, arrange for motel accommodations, restaurant facilities and availability of gasoline service stations.
- f) Provide for proper identification or nametags for all persons working on the emergency.

- g) Designate certain employees to answer telephones and handle radio dispatching. It may be necessary to provide additional telephone facilities.
- h) Sectionalize the system maps for turn off and turn on operations and determine for each section the number of customers and number of service technicians required.
- i) Group several servicemen under the supervision of a local guide who is familiar with the area.
- j) Keep a record of all pertinent facts concerning the emergency including the names of employees and the number of hours worked. He shall also keep a record of all important times such as, when all regulator stations were turned off, turn-off operations were completed, repairs were completed, gas was turned back on, purging was completed and turn-on operations were completed.

2. DUTIES OF SERVICE TECHNICIANS

- a) Be sure that all meters are valved off in the isolated section and emergency notification cards are placed on the front door of all service locations turned off advising the customer of the curtailment.
- b) Proceed to turn off interruptibles and larger industrial and commercial customers and keep a log showing customers name and time of turn off.
- c) Report back to their immediate supervisor for further instructions.

B. RESTORATION / STARTUP PROCEDURE

1. DUTIES OF SUPERVISOR IN CHARGE

a) Be sure that all repairs are made and turn offs completed before re-pressurizing the system.

- b) Notify the dispatcher at the Pipeline Company when the decision has been made to re-pressurize the system.
- c) Determine the manpower requirements for the turn on and light up operations.
- d) Notify public agencies, company personnel, insurance representatives and the general public to inform them that emergency conditions have been corrected.
- e) Accumulate all of the data about the outage for preparation of a complete report including a recap of all expenses.

2. DUTIES OF SERVICE TECHNICIANS

- a) Check evacuated buildings for the presence of gas before re-pressurizing the system.
- b) Flow gas back slowly into the system by opening the appropriate valve(s) and purging the system if necessary. Do not exceed the MAOP of the system.
- c) Turn on and light up large commercial customers and enter the turn on time on the log sheet. Top priority shall be given to hospitals and nursing homes. (Refer to Curtailment Section)
- d) Turn on and relight the remaining customers. The service technician shall leave a door hanger notice for all locations that were not turned on because customers were not home.

C. MANPOWER REQUIREMENTS

To estimate the number of personnel required to "turn off" and then "turn on" and relight a known number of meters in a reasonable length of time.

- 1. Get an estimate as to how long it will be until the system has been re-pressured and is ready for service again.
- 2. Obtain the following information:
 - a) Number of meters to be turned off and later turned back on.

- b) Number of Company employees available immediately in the area.
- c) Number of Company employees from outlying districts that can be in the area in 8 of 9 hours.
- 3. A good average figure for the Turn Off is 50 meters per man-hour. A good Average figure for the Turn On and Relight is 7.5 meters per man-hour.
- 4. Using the above information and the Work Produced Table shown below make the decision as to how long you want the work shifts to be. Keep in mind that one hour must be subtracted from the shift length for the mid-shift meal.

- 6. Multiply the figures in the Work Produced by One Person columns by 10 and the result will be the Work Produced by One Crew during the shift.
- 7. Caution: If a large number of Turn Offs is involved, say 30,000 or more it would seem advisable not to attempt to do the whole Turn Off job on one shift. The employees will be in need of rest after 11 or 12 hours and you still have two more shifts to staff.
- 8. Assuming that you decide to select the 11 hours On Duty and 13 Hours Off Duty shifts, the following table can be used to determine the number of people required to perform the Turn Off job using one, two, or three shifts.

- 9. Remember that if the shifts are more than 8 hours long they will overlap since the old shift will still be working when the new shift goes on duty at 8:00 a.m. or 4:00 p.m. or 12 midnights.
- 10. Important: Before going on to figure out how many people will be needed for the turn on & light up crews first find out how many of the people working turn offs are qualified to work re-lights safely. This will help you calculate how many qualified service technicians from outside companies will be needed to help staff the turn on and re-light crews.

VII. COORDINATION WITH LOCAL AUTHORITIES

A. EMERGENCY SITUATIONS

Whenever damage occurs during Company demolition, excavation, tunneling, or construction that involves the escape of natural gas and that may endanger life or cause serious bodily harm or danger to others, we must report this immediately to other appropriate authorities by calling the area 911 emergency telephone number.

In addition Fire and Police Department Personnel must be notified whenever:

- 1) Gas leaks create hazardous condition.
- 2) It is necessary to block off traffic or evacuate an area.
- 3) Blowing gas or spilled odorant would cause the general public to be concerned. Notification of the following authorities will be made promptly.



B. ANNUAL TRAINING

Periodic liaison shall be done with local emergency response personnel. Records of the material covered, people in attendance and Company representatives conducting the training shall be maintained.

The purpose of these meetings will be to:

- 1) Review our Emergency Plan and identify the types of gas pipeline emergencies requiring notification of public officials.
- 2) Acquaint public officials with our ability to respond to gas pipeline emergencies.
- 3) Allow us to learn about the responsibilities and resources of each police and fire department.
- 4) Plan how the Company and public officials can engage in mutual assistance to minimize hazards to life and/or property.

To insure annual training is conducted with all the appropriate agencies the proceeding list shall be reviewed and kept as current as possible.
