H2090: WIND ENERGY; SITING

Beginning on October 1, 2020, the construction or operation of a proposed individual wind turbine or other structure that requires a Federal Aviation Administration (FAA) form 7460-1 and that is part of a wind energy facility is prohibited from encroaching on or otherwise having a significant adverse impact on the mission, training or operations of any military installation or branch of military as determined by the Military Aviation and Installation Assurance Siting Clearinghouse and the FAA, and is prohibited from being constructed or expanded unless there is an active determination of no hazard from the FAA and adverse impacts to the U.S. Department of Defense have been resolved. Documentation requirements are specified. Some exceptions. The Corporation Commission is authorized to adopt rules for implementing these requirements, including administrative penalties.

S1211: ADMINISTRATIVE RULES; EXPIRATION; LEGISLATIVE EXTENSION

All "rules" (defined as a rule published in the Administrative Code) that were adopted before the effective date of this legislation expire on July 1, 2022. If an agency wishes to extend a rule that was adopted before the effective date of this legislation before the expiration of that rule, the agency is required to comply with the rulemaking procedures of the Administrative Procedures Act.

Beginning July 1, 2023, the Administrative Code expires on July 1 of each year unless the Code is approved by the Legislature for a period of up to one year.

The list of classes of transactions that are exempt from specified securities regulations is expanded to include transactions by an issuer, its parent or subsidiary companies, and their respective directors, managers, general partners, officers and employees acting as such to offer or sell securities of the issuer pursuant to specified federal code, in which the sum of the aggregate offering price and aggregate sales does not exceed \$50 million including up to \$15 million offered by all selling securityholders that are affiliates of the issuer.

S1369: VEHICLE FUELS; INFRASTRUCTURE; LEGISLATIVE AUTHORITY

The Corporation Commission and state agencies are prohibited from adopting or enforcing a state or regional program to regulate "motor vehicle fuel" for "light class motor vehicles" or "use class motor vehicles" or "fueling infrastructure" (all defined) without express legislative authority.

S1378: ELECTRICITY; GAS; DISCONNECTION PROHIBITED

A "utility" (defined) is prohibited from disconnecting any service related to heating if the temperature where the meter is located is forecasted to drop below 32 degrees fahrenheit. A utility is prohibited from disconnecting any service related to air conditioning if the temperature where the meter is located is forecasted to exceed 90 degrees fahrenheit. Utilities are required to make reasonable payment arrangements with a customer to allow for the continuation of service. Utilities are prohibited from disconnecting a customer's service if the customer's household income is at or below 200 percent of the federal poverty guidelines and the customer makes a minimum payment, or if the customer has a household with a a pregnant woman, a child who is under 5 years of age, a person who uses life support equipment, or a resident who has a disability or who is 65 years of age or older.

S1481: CAMPAIGN FINANCE; PUBLIC SERVICE CORPORATIONS

A "public service corporation," an "affiliate of a public service corporation" or a "principal" of a public service corporation or its affiliate (all defined) is prohibited from contributing directly or indirectly to a Corporation Commission candidate or candidate committee. A Corporation Commission candidate is prohibited from accepting or soliciting contributions directly or indirectly from a public service corporation, an affiliate of a public service corporation or a principal of a public service corporation or its affiliate. An expenditure by a public service corporation, an affiliate of a public service corporation or a principal of a public service corporation or its affiliate is not an independent expenditure if the expenditure is a coordinated public service corporation expenditure. Railroads operating within Arizona are required to maintain at least two operating employees in the control compartment of the lead locomotive unit of a train while the train is in motion, and at least two operating employees during remote control operations. Some exceptions.

The list of purposes for which a public body is authorized to hold an executive session is expanded to include discussion or consultations with designated representatives of the public body in order to discuss security plans, procedures, assessments, measures or systems relating to, or having an impact on, the security or safety of buildings or facilities and information technology maintained by the public body. Records, documentation, notes, or other materials made by or provided to the representatives for these purposes are confidential and exempt from public disclosure.

H2116: BEREAVEMENT LEAVE; DEATH OF CHILD

Employers are required to grant up to 2 weeks of unpaid bereavement leave during any 12-month period for an "eligible employee" (defined) to attend the funeral or burial service of the employee's "child" (defined), make any arrangements resulting from the death of the employee's child, and/or grieve the death of the employee's child. If more than one child of an eligible employee dies within a 12-month period, the total amount of leave employers must grant is increased to 6 work weeks. Requirements for taking unpaid bereavement leave are specified. Employers are prohibited from taking any adverse employment action against an eligible employee who uses bereavement leave. The Industrial Commission is authorized to impose a civil penalty of up to \$500 for a first violation and up to \$1,000 for each subsequent violation.

H2173: SMOKING REGULATION; ELECTRONIC SMOKING DEVICES

For the purposes of the statutes prohibiting smoking in all public places and places of employment in Arizona, the definition of "smoking" is expanded to include marijuana and the use of an "electronic smoking device" (defined). The list of places exempt from the prohibition on smoking in public places is modified to remove veterans and fraternal clubs when they are not open to the public and smoking as part of a theatrical performance on a stage or in the course of a film or television production. Other definitions are also modified. Due to voter protection, this legislation requires the affirmative vote of at least 3/4 of the members of each house of the Legislature for passage.

An employee who is authorized and able to provide information about any such communication is required to reply within five business days after the state agency or municipality receives that communication.

H2686: BUILDING PERMITS; UTILITIES; RESTRICTIONS; PROHIBITIONS

A county or municipality requiring the issuance of a building permit is prohibited from denying a permit application based on the utility provider proposed to provide utility service to the project. A county or municipality issuing a building permit is required to ensure that all applicable permits and fees contain requirements and amounts that do not exceed the requirements and amounts for use of other utility providers and do not have the effect of restricting a permit applicant's ability to use the services of a utility provider that is capable and authorized to provide utility service. Any code, ordinance, land use regulation or general or specific plan provision adopted by a county or municipality is prohibited from restricting a person's or entity's ability to use the services of a utility provider that is capable and authorized to provide utility

service. Counties and municipalities are prohibited from imposing a fine, penalty or other requirement that has the effect of restricting a utility provider's authority to operate or serve customers. The regulation of a utility provider's authority to operate and serve customers is a matter of statewide concern. A person's or entity's ability to use the services of a utility provider that is capable and authorized to provide utility service is not subject to further regulation by a county or municipality. Does not affect any authority of a county or municipality to manage or operate a county owned or municipally owned utility. AS SIGNED BY GOVERNOR.

The state may regulate a profession or occupation only if there is credible evidence of harm that the unregulated practice threatens the public health, safety or welfare. Regulation cannot be imposed for the exclusive purpose of protecting a profession or occupation from economic competition. Each committee of reference (COR) that reviews an agency that administers an "occupational regulation" (defined elsewhere in statute) is required to consider a specified list of factors in determining the need for continuation or termination of the agency, including the extent to which failure to regulate a profession or occupation will result in the loss of insurance, an impact to the ability to practice as required by federal law, or the loss of constitutionally afforded practices. The list of possible recommendations that the sunset review report from the COR is required to include is expanded to include recommendations that the Legislature repeal the occupational license, convert the license to a less restrictive regulation, or instruct the state agency to seek legislation or adopt rules to reflect the COR's recommendation to impose less restrictive regulations, change the requisite personal qualifications, or redefine the scope of practice. S1203: ELECTRIC CHARGING STATIONS PILOT; APPROPRIATION

The Department of Administration is required to conduct a two-year electric vehicle charging station pilot program. Arizona State University and the University of Arizona must receive monies in an amount equal to the actual cost of installing 20 electric vehicle charging stations, and Northern Arizona University and the Legislature must receive monies in an amount equal to the actual cost of installing 10 electric vehicle charging stations. The Dept is required to submit a report with specified information relating to the pilot program to the Governor and the Legislature by December 31, 2022. A county or municipality is prohibited from denying a permit application based on the utility provider proposed to serve the project. A county or municipality issuing a building permit is required to ensure that all applicable permits and fees contain requirements and amounts that do not exceed the requirements

and amounts for use of other utility providers and do not have the effect of restricting a permit applicant's ability to use the services of a utility provider that is authorized to provide service. Any code, ordinance, land use regulation or general or specific plan provision adopted by a county or municipality is required to preserve a person's or entity's ability to use the services of a utility provider that is authorized to provide service. Counties and municipalities are prohibited from imposing a fine, penalty or other requirement that has the effect of restricting a utility provider's authority to operate or serve customers.
