Pursuant to A.R.S. § 38-431.02, notice is hereby given to the hembers of the general public, the parties, and the Arizona Power Plant and Transmission Line Siting Committee ("Committee"), that the Committee will hold a public meeting/hearing on the above application that is open to the public at the DoubleTree by Hilton Tucson – Reid Park located at 445 South Alvernon Way, Tucson, Arizona 85711, commencing on Monday, July 8, 2024, at 1:00 p.m., and will continue each weekday on Tuesday, July 9, 2024, through Friday, July 19, 2024, as necessary, at the same location beginning at 9:00 a.m. on each day, unless a tour is taken. If a tour is taken, it will begin on Tuesday, July 9, 2024, at approximately 9:00 a.m. or an alternative date and time set by the Chairman of the Committee ("Chairman"). A map and itinerary of any such tour will be available at the hearing and posted on the Project website at <a href="https://www.tep.com/midtown-reliability-">https://www.tep.com/midtown-reliability-</a>
