BY THE COMMISSION:

FINDINGS OF FACT

1. TTI National, Inc. ("TTI") is certified to provide intrastate telecommunications service as a public service corporation in the State of Arizona.

2. On January 31, 2001, TTI filed tariff revisions to its Arizona Tariff No. 1:

Arizona Tariff No. 1

Table of Contents, Page 2, Release 9
Section 4, Page 27, Release 2

Arizona Price List No. 1

Page PL-1, Release 4

3. This filing increases the interexchange "Directory Assistance Charge" in TTI's price list to \$1.99 from \$1.40. This filing also increases the maximum rate set for interexchange directory assistance to \$4.00 from \$1.10.

4. Since this filing increases the maximum rates for a component of a service that has been classified as competitive under the Commission's Competitive Telecommunications Services Rules, A.A.C. Rule R14-2-1110 applies to TTI's proposal.

5. Staff requested information from TTI to allow it to determine the potential effects of approval of the filing. TTI provided information that indicates that the expected revenue effect of

1 approval of this filing is an increase of \$353 per month. This is an increase of 0.6 percent in TTI's
2 Arizona revenues.

3 CONCLUSIONS OF LAW

4 1. TTI is an Arizona public service corporation within the meaning of Article XV, Section
5 2, of the Arizona Constitution.



6 2. The Commission has jurisdiction over TTI and over the subject matter of the application.

7 ORDER


8 THEREFORE, IT IS ORDERED that the filing be and hereby is denied.
