Pursuant to A.R.S. § 38-431.02, notice is hereby given to the members of the general public, the parties and the Arizona Power Plant and Transmission Line Siting Committee ("Committee") that the Committee will hold a meeting/hearing on the above numbered application that is open to the public on Tuesday, June 2, 2009, at 9:30 a.m. at the Esplendor Resort at Rio Rico, 1069 Camino Caralampi, Rio Rico, Arizona 85648; telephone: (520) 281-1901. The hearing will continue on Wednesday, June 3, 2009, at 8:30 a.m. The hearing will adjourn at approximately 5:00 p.m. each day. Public comment will be taken during the hearing at times designated by the Chairman. Public comment also will be taken in a special evening session on June 2, 2009, at 6:00 p.m. at the same location. If needed, the hearing will continue on Thursday, June 4, 2009, at 9:30 a.m. Additional days for the hearing may be set, or the hearing may conclude earlier than anticipated, depending upon the number of parties that intervene, the amount of testimony presented, the amount of public comment, and the time needed for deliberations by the Committee. As a part of the public meeting/hearing, members of the Committee will discuss the potential value of a tour, and, at the discretion of the Chairman of the Committee, may tour the proposed route for the project on June 3, 2009, beginning at 8:30 a.m. At the meeting/hearing, the Committee may consider, discuss, deliberate and/or vote on the matters on the Agenda. No testimony or discussion with or between Committee Members about the Application or matters relating to the Application will take place, except on the record before a court reporter at the designated stops. The Chairman of the Committee will make any procedural decisions concerning stops at different points of interest;
