Pursuant to A.R.S. § 38-431.02, notice is hereby given to the members of the general public, the parties and the Arizona Power Plant and Transmission Line Siting Committee ("Committee"), that the Committee will hold a public meeting/hearing on the above application that is open to the public at the Hampton Inn & Suites – Yuma, 1600 E. 16<sup>th</sup> Street, Yuma, Arizona 85365, on Monday, September 12, 2016 at 9:30 a.m., and as necessary on Tuesday, September 13, 2016 at 9:30 a.m., unless a tour is taken. If a tour is taken, it will begin on Monday, September 12, 2016, at approximately 1:30 p.m. or an alternative date and time set by the Chairman. Public comment may be taken during the hearing at times designated by the Chairman. Unless later ordered by the Chairman, the hearing will adjourn at approximately 5:00 p.m. each day.

Additional days for the hearing may be set, and the hearing may conclude earlier or later than anticipated, depending upon the number of parties that intervene, the amount of testimony presented, the amount of public comment, and the time needed for deliberations by the Committee. As a part of the public meeting/hearing,

members of the Committee will discuss the potential value of a tour, and, at the discretion of the Chairman, may tour the location of the proposed power plants and transmission lines for the project as set forth above.

- Vote and decision concerning findings of fact, conclusions of law, the certificate of environmental compatibility and conditions to the certificate of environmental compatibility; and
- 10. Adjournment.
