ORDER REVOKING SECURITIES
DEALER REGISTRATION

I.

INTRODUCTION

On December 16, 1998, the Securities Division ("the Division") of the Arizona Corporation Commission ("the Commission") filed a Notice for Hearing Regarding Proposed Order of Revocation ("the Notice") against MEYERS POLLACK ROBBINS, INC. ("MPR"). The Notice specified that MPR would be afforded an opportunity for an administrative hearing regarding this matter upon filing a written request with Docket Control of the Commission within ten (10) days of receipt of the Notice. MPR failed to request a hearing within the required time.

II.

FINDINGS OF FACT

1. MPR, whose last known address is One World Trade Center, Suite 9151, New York, New York 10048, has been registered with the Commission as a securities dealer from on or about October 6, 1992 to December 31, 1998.

2. On or about August 5, 1998, the National Association of Securities Dealers expelled MPR for failure to pay fines and/or costs in NASD Complaint No. C04970030.

4 ORDER

5 Therefore, on the basis of the Findings of Fact and Conclusions of Law, the Commission
6 finds that the following Order is appropriate, in the public interest and necessary for the protection of
7 investors.

8 IT IS HEREBY ORDERED that the securities dealer registration of MPR be revoked. This
9 Order shall become effective within ten days unless a motion for rehearing is filed pursuant to
10 A.A.C. R14-3-112.
