The Order and Consent provided for restitution payments by Respondent STEVEN LYLE BELDEN ("BELDEN") to be placed in a trust account maintained and controlled by the Arizona Attorney General's Office, for disbursement by the Attorney General's Office on a pro rata basis to investors as reflected in the records of the Division.






1 payments pursuant to Decision No. 57581 shall be deposited into an interest-bearing account to be


