BY THE COMMISSION:

FINDINGS OF FACT

1. On July 25, 2001, the Arizona Corporation Commission ("Commission") issued Decision No. 63873 ("Decision") in the above-captioned matter.

2. On August 3, 2001, pursuant to A.A.C. R14-3-112, Respondent Gareth N. Patton filed with the Commission an Application for Rehearing and Review ("Application") of the Decision on the grounds that the Decision is not justified by the evidence and is contrary to law.

3. On August 9, 2001, the Commission's Securities Division ("Division") filed its response and requested that the Application filed by Mr. Patton be denied on the basis that the Decision is based on the evidence and is not contrary to law.

1 4. The Division's request to deny the Application is well made and should be adopted.

2 CONCLUSIONS OF LAW

3 1. The Commission has jurisdiction over this matter pursuant to Article XV of the Arizona  
4 Constitution, A.R.S. §§ 44-1801 et seq. And A.A.C. R14-3-112.

5 2. The Respondent has not demonstrated adequate grounds to justify further review of the  
6 Decision pursuant to A.A.C. R14-3-112.




7 3. The Application as filed by the Respondent should be denied.

8 ORDER


9 IT IS THEREFORE ORDERED that the Application for Rehearing and Review of Mr.
