RE: **ESTIMATE OF GROSS OPERATING REVENUES; COMPLIANCE
WITH ARIZONA REVISED STATUTES, SECTION 40-401.E**

Arizona Revised Statute, Section 40-401, Paragraph E, requires that:

Each public service corporation with gross operating revenues greater than five hundred thousand dollars (\$500,000) shall on or before **January 10, 2019**, file with the Arizona Corporation Commission a statement showing its **estimated** gross operating revenues derived from **intrastate** operations during the preceding calendar year (2018).

This reporting requirement is separate from the requirement that all public service corporations file by May 1, 2018, a sworn statement of actual intrastate gross operating revenues for the previous calendar year (2018).

ARIZONA CORPORATION COMMISSION DECISION NO. 41725, REQUIRES THAT STATE AND LOCAL SALES TAXES COLLECTED (OR BILLED) BE INCLUDED IN GROSS OPERATING REVENUES USED TO DETERMINE REGULATORY ASSESSMENTS. HOWEVER, FEDERAL EXCISE TAXES BILLED OR COLLECTED ARE NOT TO BE INCLUDED IN GROSS OPERATING REVENUES.
