If a tour is taken, it will begin on an 24 alternative date and time set by the Chairman of the Committee ("Chairman").

Public comment will be taken in a special evening session on January 13, 2025, at 5:30 p.m. and may be taken at the beginning of each hearing day or at other times during the hearing at times designated by the Chairman. Unless later ordered by the Chairman,

the hearing will adjourn at approximately 5:00 p.m. each day, except on January 13, 2025, when it will continue after 5:30 p.m. for the public comment session.

No tour of the Project area is planned by the Chairman at this time.
