Pursuant to A.R.S. § 38-431.02, notice is hereby given to the members of the general public, the parties, and the Arizona Power Plant and Transmission Line Siting Committee ("Committee"), that the Committee will hold a public meeting/hearing on the above application that is open to the public at Arizona Corporation Commission ("ACC"), located at 1200 West Washington Street, Phoenix, Arizona, 85007 commencing on October 15, 2024, at 9:00 a.m., and will continue on October 16, 2024, at the same location beginning at 9:00 a.m.

Public comment will be taken in a special evening session on October 15, 2024, at 5:30 p.m. and may be taken at the beginning of each hearing day or at other times during the hearing at times designated by the Chairman. Unless later ordered by the Chairman, the hearing will adjourn at approximately 5:00 p.m. each day, except on October 15, 2024, when it will continue after 5:30 p.m. for the public comment session.

No tour of the Project area is planned by the Chairman at this time. If the Chairman or Committee later decides to conduct a tour, notice that includes a map and itinerary of any such tour will be available at the hearing and posted on the Project website at https://ltdpowerglobal.com/atlas-north/ and the ACC website at: https://www.azcc.gov/arizona-power-plant/meeting-schedule.

The hearing may conclude earlier or later than anticipated, depending upon the number of parties that intervene, the amount of testimony presented, the amount of public

comment, and the time needed for deliberations by the Committee. As a part of the public meeting/hearing, members of the Committee will discuss the potential value of a tour, and, at the discretion of the Chairman, may tour the location of the proposed project area as set forth above.

The Chairman will make any procedural decisions concerning stops at different points of interest;
- 8. Discussion of proposed findings of fact, conclusions of law, the certificate of environmental compatibility and conditions to the certificate of environmental compatibility;
- 9. Vote and decision concerning findings of fact, conclusions of law, the certificate of environmental compatibility and conditions to the certificate of environmental compatibility;
- 10. Adjournment.
