Pursuant to A.R.S. § 38-431.02, notice is hereby given to the members of the general public, the parties and the Arizona Power Plant and Transmission Line Siting Committee (“Committee”), that the Committee will hold a public meeting/hearing on the above application that is open to the public at the Hampton Inn & Suites, located at 2000 North Litchfield Road, Goodyear, Arizona 85395, commencing on October 4, 2021 at 1:00 p.m., and will continue each weekday on October 5, 2021, through October 8, 2021, as necessary, at the same location beginning at 9:00 a.m. on each day.

No tour of the Project area is planned by the Chairman at this time. If the Chairman or Committee later decide to conduct a tour, notice that includes a map and itinerary of any such tour will be available at the hearing and posted on the Project website at www.aps.com/threerivers and the ACC website at: <https://www.azcc.gov/arizona-power-plant/meeting-schedule>.

1 The hearing may conclude earlier or later than anticipated, depending upon the
2 number of parties that intervene, the amount of testimony presented, the amount of public
3 comment, and the time needed for deliberations by the Committee. As a part of the public
4 meeting/hearing, members of the Committee will discuss the potential value of a tour, and,
5 at the discretion of the Chairman, may tour the location of the proposed project area as set
6 forth above.

22 decisions concerning stops at different points of interest;

24 environmental compatibility and conditions to the certificate of
25 environmental compatibility;
- 26 9. Vote and decision concerning findings of fact, conclusions of law, the
27 certificate of environmental compatibility and conditions to the certificate of
28 environmental compatibility;
10. Adjournment.
