15 Pursuant to A.R.S. § 38-431.02, notice is hereby given to the members of the  
16 general public, the parties, and the Arizona Power Plant and Transmission Line Siting  
17 Committee (“Committee”), that the Committee will hold a public meeting/hearing on the  
18 above application that is open to the public at the DoubleTree by Hilton,  
19 Coconino/Canyon Room, located at 1175 West Route 66, Flagstaff, Arizona 86001,  
20 commencing on December 9, 2024, at 1:00 p.m., and will continue each weekday on  
21 December 10 through December 13, 2024, as necessary, at the same location beginning at  
22 9:00 a.m. on each day, unless a tour is taken. If a tour is taken, it will begin an alternative  
23 date and time set by the Chairman of the Committee (“Chairman”).

24 Public comment will be taken in a special evening session on December 9, 2024, at  
25 5:30 p.m. and may be taken at the beginning of each hearing day or at other times during  
26 the hearing at times designated by the Chairman. Unless later ordered by the Chairman,  
27 the hearing will adjourn at approximately 5:00 p.m. each day, except on December 9,  
28 2024, when it will continue after 5:30 p.m. for the public comment session.

1 No tour of the Project area is planned by the Chairman at this time. If the  
2 Chairman or Committee later decides to conduct a tour, notice that includes a map and  
3 itinerary of any such tour will be available at the hearing and posted on the Project website  
4 at <https://www.clenera.com/projects/snowflakesolarcomplex> and the Arizona Corporation  
5 Commission's ("ACC") website at: [https://www.azcc.gov/arizona-power-plant/meeting-](https://www.azcc.gov/arizona-power-plant/meeting-schedule)

7 The hearing may conclude earlier or later than anticipated, depending upon the  
8 number of parties that intervene, the amount of testimony presented, the amount of public  
9 comment, and the time needed for deliberations by the Committee. As a part of the public  
10 meeting/hearing, members of the Committee will discuss the potential value of a tour, and,  
11 at the discretion of the Chairman, may tour the location of the proposed project area as set  
12 forth above.

14 **WATCHING THE MEETING ONLINE OR LISTENING TO THE MEETING VIA**  
15 **TELEPHONE.**

16 At least 24 hours in advance of the hearing, information regarding online and  
17 telephone hearing access as well as any additional details regarding safety protocols or  
18 other revisions to the hearing schedule, will be posted on the Applicant's Project website

21 discretion, recess the hearing to a time and place to be announced during the hearing, or to

23 resumed will be posted on the above-noted Project and ACC websites. **NOTE: NOTICE**  
24 **OF ANY SUCH RESUMED HEARING WILL BE GIVEN; HOWEVER,**  
25 **PUBLISHED NOTICE OF SUCH A RESUMED HEARING IS NOT REQUIRED.**

26 **PUBLIC COMMENT WILL BE TAKEN IN A SPECIAL EVENING**

1 **FLAGSTAFF, ARIZONA 86001. PUBLIC COMMENT MAY BE TAKEN AT THE**  
2 **BEGINNING OF EACH HEARING DAY, OR AT OTHER TIMES DURING THE**  
3 **HEARING, AT THE DISCRETION OF THE COMMITTEE CHAIRMAN.**

4 **PLEASE BE ADVISED THAT ALL LOCAL AND STATE PUBLIC**  
5 **HEALTH AND SAFETY GUIDELINES WILL BE FOLLOWED DURING THE**  
6 **PUBLIC HEARING AND PUBLIC COMMENT SESSION. RESTRICTIONS ON**

10 At the public meeting/hearing, the Committee may consider, discuss, deliberate

- 15 3. Consideration of and vote upon any requests to intervene;
- 16 4. Hearing on the application;
- 17 5. Public comment at the discretion of the Chairman;
- 18 6. Discussion of potential value of a tour of the proposed route;
- 19 7. If it is decided a tour would be valuable, the Committee will meet at the  
20 hearing site. The members of the Committee will tour the project. Members  
21 of the public may follow the Committee's tour. No testimony or discussion  
22 with or between Committee members about the application or matters  
23 relating to the application will take place, except on the record before a court  
24 reporter at the designated stops. The Chairman will make any procedural  
25 decisions concerning stops at different points of interest;
- 26 8. Discussion of proposed findings of fact, conclusions of law, the certificate of  
27 environmental compatibility and conditions to the certificate of  
28 environmental compatibility;
