
BEFORE THE ARIZONA POWER PLANT AND TRANSMISSION LINE SITING COMMITTEE

IN THE MATTER OF THE APPLICATION OF 311SV 8ME LLC, IN CONFORMANCE WITH THE REQUIREMENTS OF ARIZONA REVISED STATUTES 40-360 ET. SEQ., FOR A CERTIFICATE OF ENVIRONMENTAL COMPATIBILITY AUTHORIZING THE CONSTRUCTION OF THE CATCLAW SOLAR 230-KV GENERATION INTERTIE PROJECT LOCATED IN BUCKEYE, MARICOPA COUNTY, ARIZONA.



Pursuant to A.R.S. § 38-431.02, notice is hereby given to the members of the general public, the parties and the Arizona Power Plant and Transmission Line Siting Committee ("Committee"), that the Committee will hold a public meeting/hearing on the above application that is open to the public at the Hilton Garden Inn, located at 11460 West Hilton Way, Avondale, Arizona 85323, commencing on Wednesday, June 7, 2023, at 9:00 a.m., and will continue, as necessary, on Thursday, June 8, 2023, and Friday, June 9, 2023 at the same location beginning at 9:30 a.m., unless a tour is taken. If a tour is taken, it will begin on an alternative date and time set by the Chairman of the Committee ("Chairman").

Public comment will be taken in a special evening session on Wednesday, June 7, 2023, at 5:30 p.m. and may be taken at the beginning of each hearing day or at other times during the hearing at times designated by the Chairman. Unless later ordered by the Chairman, the hearing will adjourn at approximately 5:00 p.m. each day, except on June 7, 2023, when it will continue after 5:00 p.m. for the public comment session.

No tour of the Project area is planned by the Chairman at this time. If the Chairman or Committee later decides to conduct a tour, notice that includes a map and itinerary of any such tour will be available at the hearing and posted on the Project website

The hearing may conclude earlier or later than anticipated, depending upon the number of parties that intervene, the amount of testimony presented, the amount of public comment, and the time needed for deliberations by the Committee. As a part of the public meeting/hearing, members of the Committee will discuss the potential value of a tour, and, at the discretion of the Chairman, may tour the location of the proposed project area as set forth above.

THE PUBLIC HAS THE OPTION TO PARTICIPATE BY EITHER WATCHING THE MEETING ONLINE OR LISTENING TO THE MEETING VIA TELEPHONE.

At least 24 hours in advance of the hearing, information regarding online and telephone hearing access as well as any additional details regarding safety protocols or other revisions to the hearing schedule, will be posted on the Applicant's Project website at https://www.catclawsolar.com and Arizona Corporation Commission's ("ACC") website at https://www.azcc.gov/arizona-power-plant/meeting-schedule. The Chairman may, at his discretion, recess the hearing to a time and place to be announced during the hearing, or to be determined after the recess. The date, time, and place at which the hearing will be resumed will be posted on the above-noted Project and ACC websites.

NOTE: NOTICE OF ANY SUCH RESUMED HEARING WILL BE GIVEN; HOWEVER, PUBLISHED NOTICE OF SUCH A RESUMED HEARING IS NOT REQUIRED.

PUBLIC COMMENT WILL BE TAKEN IN A SPECIAL EVENING SESSION ON WEDNESDAY JUNE 7, 2023, AT 5:30 P.M., VIA TELEPHONE, ZOOM, OR IN PERSON AT THE HILTON GARDEN INN LOCATED AT 11460 WEST HILTON WAY, AVONDALE, ARIZONA 85323. PUBLIC COMMENT MAY ALSO BE TAKEN AT OTHER TIMES DURING THE HEARING AT THE DISCRETION OF THE COMMITTEE CHAIRMAN.

PLEASE BE ADVISED THAT ALL LOCAL AND STATE PUBLIC HEALTH AND SAFETY GUIDELINES WILL BE FOLLOWED DURING THE PUBLIC HEARING AND PUBLIC COMMENT SESSION. RESTRICTIONS ON PUBLIC ACCESS, SAFETY PROTOCOLS, AND REVISIONS TO THE HEARING SCHEDULE MAY OCCUR DUE TO PUBLIC HEALTH CONSIDERATIONS.

At the public meeting/hearing, the Committee may consider, discuss, deliberate and/or vote on the matters on the agenda. Items on the agenda may be taken in a different order than listed as conditions require:

- 1. Call to order;
- 2. Roll call;
- 3. Consideration of and vote upon any requests to intervene;
- 4. Hearing on the application;
- 5. Public comment at the discretion of the Chairman;
- 6. Discussion of potential value of a tour of the proposed route;
- 7. If it is decided a tour would be valuable, the Committee will meet at the hearing site. The members of the Committee will tour the project. Members of the public may follow the Committee's tour. No testimony or discussion with or between Committee members about the application or matters relating to the application will take place, except on the record before a court reporter at the designated stops. The Chairman will make any procedural decisions concerning stops at different points of interest;
- 8. Discussion of proposed findings of fact, conclusions of law, the certificate of environmental compatibility and conditions to the certificate of environmental compatibility;
- 9. Vote and decision concerning findings of fact, conclusions of law, the certificate of environmental compatibility and conditions to the certificate of environmental compatibility;
- 10: Adjournment.
