20 approved, no representative of the party will receive service by U.S. Mail from a Commissioner, the
21 Commission's Executive Director, or a Commission Division unless and until this Consent to
22 Email Service is withdrawn through a subsequent filing.¹

23 The party further understands and agrees that each email providing service of a filing may
24 include a link to access the filing online rather than an electronic copy of the filing and, further, that
25 the receipt of such an email may occur either on the date the filing is made or as soon as possible
26 thereafter.

16 the filing with a service certification including coding indicating that an automatic service email for
17 the filing shall be sent to each party whose consent to email service has been approved.

20 The party further understands and agrees that the party will no longer receive service in this
